GOLF OUTING TERMS AND CONDITIONS:

Duncan Hills Golf Course recommends at least 36 players to consider an 18-hole shotgun start. Less than 36 players may start using a modified shotgun start or tee times (Modified shotgun: A shotgun start in which a portion of the 18-holes is occupied in order for the club to open the remainder of the facility for public play).

PAYMENT

In order to reserve the date and time indicated above, I understand and by my signature on this Contract, hereby agree to the following terms:

- This Golf Event Contract must be signed and returned with a \$200.00 DEPOSIT to formally secure the requested outing date. This deposit can be paid with cash, check or credit card. Please make checks payable to Duncan Hills Golf Course. (NOTE: This deposit will be applied against the final bill).
- The FINAL GUARANTEE for all golfers, including all outing volunteers, must be due 7 (seven) days prior to the event date. The guaranteed number is not subject to reduction. Groups arriving with fewer than the guaranteed number of golfers will be charged for the final guaranteed number.
- The FINAL BALANCE must be paid in full no later than end of day on the event date. This amount can be paid with cash, check or credit card. Please make checks payable to Duncan Hills Golf Course. Groups may request an invoice following the event in which payment is due within 30 days of the invoice.

PLAYER COUNT OR LIST

A "player list" or a "pairing list" must be mailed/emailed to the head golf professional no later than three days prior to your Golf Outing Date (EMAIL: duncanhillspro@gmail.com). We ask for your full cooperation so that our staff can prepare for the event.

DRESS CODE

- Golfers are required to wear shirts, pants / shorts and shoes.
- Duncan Hills Golf Course is a "spike-less" facility and all players must wear appropriate soft spike golf shoes or sneakers.

FOOD AND BEVERAGE

- To ensure availability of menu items and staffing, your catering services must be booked and confirmed with DHGC management two weeks before your event.
- No outside alcoholic beverages may be brought on the facility for consumption.
- All alcoholic beverages must be provided and served by Duncan Hills employees. No alcoholic beverages are permitted to leave the facility.
- The legal drinking age in Missouri is 21 for all alcoholic beverages. In accordance with Missouri laws, we reserve the right of our staff to assess the level of alcohol consumption and act accordingly.

INCLEMENT WEATHER

- Cancellation of the outing will be considered on the day of the event and only if Duncan Hills Golf Course officially closes the course to all play.
- Cancellations must be discussed with golf course management.
- The tournament will be rescheduled based on date availability and/or requested rain date.
- Groups cancelling within eight days of the event will forfeit their deposit.

SIGNAGE

- Duncan Hills Golf Course will place and remove at no additional cost, any signage utilized by the tournament.
- Signage must be claimed by each event and removed from the property at the conclusion of the event. After 72 hours, all signage left beyond that time will be discarded.

CANCELATION POLICY

- It is the sole discretion of Duncan Hills Golf Course to determine if weather is cause for cancellation on the day of the event. If, in our opinion, an event must be cancelled you will have the option to schedule another day.
- Once an event begins, there will be no refunds unless the course is closed by the officials on site.

INDEMNIFICATION

Client hereby jointly and severally agrees to indemnify, defend and hold Duncan Hills Golf Course and the City of Savannah harmless from all claims, suits, actions at law, judgments, liabilities, losses and damages (including attorney's fees) arising from the use of Duncan Hills Golf Course property, however caused, including without limitations, any injury or damages resulting from negligent, careless, improper or unlawful conduct.

DAMAGES

We agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts) and utilizing the golf course property. In the event that we cause damage to the property and/or equipment used by our participants, we agree to pay in full for any damages.
